PRESIDENT'S LETTER

Well, It was the old 1-2-3-punch for preservation in Fairmount this past month. 1900 5th Avenue was torn down last Tuesday. September 8th. Many are happy, or at least relieved. that the eyesore has been removed. I share in those feelings to a point. In retrospect, however, I am more saddened and then angry than anything else. I look upon the whole thing as a horrible tragedy. For more than nine years numerous people fought to save 1900 and return it to the showplace it once was. In the end, it became a tumor that had to be removed. That is a complete travesty. I am reminded of some other, magnificent homes in Fairmount: Jacqueline Bender's home on 6th. Jerre Cotton's house on College. Marianna Thrapp's on Alston, and Rodney Wade's on Adams. Can any of us imagine Fairmount without them? The homes in Fairmount are like old embroidery. Parts of it are in very bad repair and instead of taking the time to restore one of the damaged areas, they've just been ripped out. Now all that can be seen is stamped pattern underneath the thread. New thread will be added to try to match the old, but it will never again have the same value to a collector. It will never have the same charm it did before. Fairmount may be a safer place now that 1900 is gone, but it is, in my opinion, a much poorer place for it. From a "green" standpoint, the fact that none of the siding or the columns or any other parts could be salvaged is also disheartening. Some of that wood had truly stood the test of time.

We also lost the Brace Building at the comer of 8th and Magnolia. Although not technically within Fairmount, it was still a part of our Near Southside history. It too must be replaced, and it is up to us to ensure that we do our utmost to have a building there that is both useful and aesthetically harmonious with remaining old buildings on Magnolia.

Our third loss this month was out in the 1400 block of Fairmount, which burned several months back and was not able to be saved. And the fourth loss has yet to happen, but will in the next few weeks to a small 1915 bungalow at the very end of Lake that is also the result of neglect like 1900.

The very fabric of our neighborhood is at stake here. We MUST take to heart all of the endangered homes in Fairmount and resolve to stop any further deterioration of our most valuable treasure, our homes.

On a more positive note, if you haven't been to the Fairmount Happy hour yet, please put it on your calendar. Spurred by the inexhaustible efforts of Sean and Sara Lynch, the first one at Cafe Chadra was a huge success. Please come meet your friends, neighbors, and Fairmount directors. It's a great way to network and make known your concerns and issues so that we can all work toward a common goal.

I think the keyword for the next two years is going to be teamwork. And to be an effective team, we need to get everyone off the bench and onto the field. Please volunteer in any way you can; and, if you know of anyone, old or new, to Fairmount, who is not a member or may not be aware of any volunteer opportunities, please invite them to the next neighborhood function and help us make them feel welcome and appreciated. We're in this together. No one but we, ourselves, can make a difference and work to improve the quality of life in Fairmount. And as always, my phone is always on and my e-mail always available for any concerns you may have. I intend my new role as president to be one of service to the neighborhood and its residents. Please help me fulfill that role. See you at the next meeting.

OUTSIDE YOUR OLD HOUSE

As you're reading this, it's nearly October. Spring is sprung, fall is fell! The leaves are beginning to turn.

This is the time to divide and replant your perennials. If you have poppy and/or larkspur seed, you can begin to plant them in October or November as long as the weather has begun to cool. Once established, they will reseed themselves.

If you haven't already, put com gluten on your lawn as a pre-emergent for spring weeds.

Plant roses and other spring blooming shrubs now. If

you love roses, go with the antiques: they are virtually trouble free and will reward you with both bloom and fragrance. I'm not really familiar with Chamblee's website but the Antique Rose Emporium lists all their roses so you can pick by type, color, fragrance and whether they rebloom.

You can go ahead and plant cool season annuals now: pansies, snapdrag-

ons, kales and cabbages and dianthus.

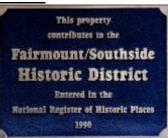
As the leaves begin to fall, do yourself and your garden a big favor and invest in a mulching leaf vacuum. All those leaves that fall make wonderful mulch for the winter and feed your garden beds as they break down. Until you get your cycle going you may need to add high nitrogen fertilizer for your blooming plants—any mulch uses a lot of the available nitrogen to break down.

Did you plant fall vegetables? Keep them mulched and you should be able to harvest until the first freeze. Carrots and other tubers could last thru several freezes. Incidentally, if you've never tried parsnips, take a chance. They're much better than they sound.

Enjoy the cooler crisp weather. This is the beginning of planning time! Enjoy!!!

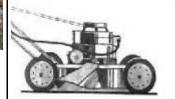

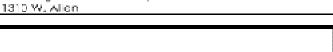

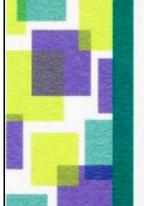

The questions have been raised many times in the past few months, "When should I call 911?" and "What is considered suspicious behavior?" This month I wanted to answer these questions and give some helpful advice for what to look for and what information to provide when you call 911.

Keep in mind that when you call 911, you will speak with a call taker. The call takers job is to prioritize the call and pass the information on to a Police Dispatcher. Once the dispatcher receives the information a call will be set up and an Officer will be sent to the call location. Officer response time will be determined in large part by Officer availability and based upon the priority level the call was given by the call taker.

Now let's discuss 'suspicious behavior'. Anything that seems strange to you would be considered suspicious behavior. Anything that makes you stop and think, "I wonder what he/she is doing", would be considered suspicious behavior. These are the best guidelines to follow and you have to remember that if something looks, feels, smells or sounds strange to you then it is "suspicious."

Now that everyone is on the same page with the definition of suspicious behavior, answering the question of "When should I call 911" is very easy. I want you to call 911 and have an Officer come out anytime you see, smell,or hear something suspicious or when you have a feeling that something is suspicious!

Here are some things you need to pay attention to and make the call taker aware of when you call:

For Persons—race, age, height, hair description, facial hair, glass/no glasses, clothing description, shoe description, bags/backpacks, direction of travel, behavior and demeanor if you spoke with the person

For Vehicles—use the CYMBAL acronym: C = Color, Y = Year, M = Vehicle Make (Ford, Chevrolet, etc.), B = Body Style (Van, Pick-up, etc.), A = Additional Details (direction of travel, damage, bumper stickers, etc.), L = License Number (even partial plate numbers are helpful)

Thank you all so much for the help you provide to the Police Department and your neighbors. Keep up the good work and remember: Be safe today and safer tomorrow.



OCTOBER YARD OF THE MONTH – 2010 6TH AVE.

This month we choose as Yard of The Month to honor the home of Natalie and Lee Reeves at 2010 6th Avenue. The recently-married couple has worked hard to make the outside of their home as charming as the inside, which was featured during the 2008 Fairmount Historic Home Tour.

Rows of Hawthorne Shrubs line the porch forming an evergreen background for the Apricot Princess Roses which are blooming beautifully right now. More color is provided by the vivid lime green leaves of the Sweet Potato Vines which crawl along the beds in front of the Roses and the Begonias. Geraniums bloom abundantly in the beds surrounding the trees between the sidewalk and street. The newly-installed lawn is a beautiful and environmentally friendly Zoysia variety developed by A & M University. The turf is slow-growing and drought tolerant, requiring less water, fertilizer, and mowing than conventional lawns.



The porch is decorated with a pair of hanging baskets overflowing with Moss Rose. A pair of single-seat swings anchors one end of the porch, while a two seat swing anchors the other end. Between the swings are four Adirondack Chairs painted in white and red.

DECLINE AND FALL: THE SAD DEMISE OF 1900 5TH AVENUE, 1911—2009

I used to live three houses down from 1900 5th in 1983-1985 when it was a boarding house packed with noisy undesirable people who paid by the week. Some time in the next year or so after we bought our house in the same block of 6th, 1900 5th was left open and abandoned, with weeds and trash always in the yard. After many complaints to Code, the house was finally boarded up by the City. We gave up calling it in for high grass and weeds and took it into our own hands. It was often the starting point for Fairmount Neighborhood deanups even though Southside Preservation Hall's community service volunteers were sent there weekly to dean up the littler of bottles and needles, and hauled away the falling debris as it composted for years before our very eyes. I moved it myself one year the day before home tour.



Meanwhile the Tarrant County Appraisal District kept raising the assessment automatically, obviously without ever looking at it, until the day it was demolished at an appraised value of \$83,000! Over the years people begged the owner to sell, people willing to pour \$100,000 or more into it, knowing they could turn it into a showplace. Because of its size, conspicuous corner lot location, plus the huge garage apartment, it would have still made a profit. But the owner refused to see for less than the appraisal for a price. One actually got the owner to accept a deal for \$20,000, but he never showed up to the closing.

About 10 years ago, our restoration experts said it was too far gone to save when we had meetings with the City, Code Enforcement, Lawyers, and our City Councilperson. When the City decided to start proceedings to seize it for back taxes and mowing liens, it was discovered to be collateral which was tied up in a lawsuit which took years to resolve. Then the owner filed bank-

ruptcy, daimed incompetence and all his properties were put into a trust. Code finally was able to intervene due to public safety concerns. The Trust was required to erect a fence and start restoration by a certain date – but only the fence got put up. So Code finally took it to the Landmarks Commission in November 2007 for demolition, and it was approved. The owner has been appealing that decision all the way to the Texas Supreme Court, claiming it was his family home and that he intended to restore it. Finally with all appeals exhausted, and after more than 20 years of neglect and decay, the City demolished the structures on Tuesday, September 8, 2009.

From what we understand, the City will maintain custody of the land for a year, giving the owner time to daim it by paying 1½ times what is owed. At that time, the City will sell it to the high bidder with a discounted reasonable opening bid. Hopefully one of our great new-old-home builders will snap it up and build a house Fairmount can be proud



of again. One even told me, he would like to replicate the original. Wouldn't that be grand! Until then, my hope is that the neighbors will be so relieved we will keep the lot up, making it the best looking vacant lot in Fairmount.

Many thanks to all who persevered for Fairmount from City officials to City Councilpersons to Restorationists, Realtors,



and many a Fairmount board member. Thank you to the neighbors who endured its embarrassing presence all these many years. And thank you to those who deaned up after it, and kept this photographic history. Several City Staffers were there for the demolition, some saying they had worked this issue their entire careers! And that evening a line of neighbors sat in lawn chairs across the street celebrating their new and improved view, and yet wistful that it all was such a waste. It's the sort of victory that preservationists hate. We finally won the war, but lost the victim. Farewell, 1900 5th. We knew you well. You could have been alive and beautiful again, but were sacrificed for no good reason.
