- Chewy Redding, Financial: \$3000 net income for month. Cash total \$44,864.59
- Serena Keeler, Administration: Block captain and welcome packet information. She wants feedback from hood to see if there is enough interest in participating in the free parkway tree program this year. We have planted over 400 trees in the past three years.
- David Thrapp, Public Safety: Alley closure information and applications. There is no city funding for alleys to be mowed. Cannot build on alleys. It is still an easement. 100% of neighbors on your street have to sign petition to obtain closure permission. Flags for lamppost update. Gas lease update.
- Sean Lynch, Infrastructure: Clean up on Allen and happy hour update.
- Kevin Buchanan, Promotions: Looking for Fairmount photos to post on Facebook of events, etc.
- Sue McLean, Historic Preservation: Do you have an old picture of your house? Email it to Sue. We have been able to stop the demolition at 1405 Fairmount for the moment. This property is savable. A Preservation Task Force is being set up to try to save endangered properties in the neighborhood.

Presentation: Deborah Rogers 7:45-8:30

Deborah Rogers is a goat farmer and a member of the Fort Worth League of Neighborhoods. She lives on her family farm on the west side of Fort Worth. Cheseapke has a 12 drill pad site next to her property. The city of Fort Worth and The Texas Commission on Environmental Quality (TCEQ) are not required and therefore have not done any environmental impact studies to know the possible impact on air and water quality due to urban drilling. Deborah has spent \$30,000 of her own money to get air and water quality testing for her farm. She did a baseline study of before drilling and testing done while drilling. She has seen a significant increase in chemicals such as benzene (a carcinogenic) and other neuron toxins in the air and in her well water. The DFW airport negotiated a lease that has "no emissions technologies" or "green completion" provisions. What this means is that the emissions are captured, no flaring is allowed, numatic valves are installed, vapor recovery systems are in place. The gas industry is exempt from the clean air act and other environmental laws. Neighborhoods need to negotiate for these things in their leases. Gas companies will not just volunteer to do the right thing. Individuals have to make sure these provisions are in the lease they sign. Insist on "No emissions technology," "No flaring," "Numatic valves," "Vapor recovery systems" and "Green completion." Deborah also believes we still don't have clear answers on how hydraulic fracing will / is impacting our water quality. Or if chemicals are migrating into our aquifer and the effects of run off. She also encouraged us to continue placing pressure on our elected officials to do the right thing and to hold our officials and gas companies accountable.



OUTSIDE YOUR OLD HOUSE

Susan Harper

We can only hope that this heat has broken by the time you read this! It's been so hot, even thinking about gardening is daunting. However, if you want those lovely fresh fall vegetables, this is the time to plant. There is a spreadsheet attached to the Fall Vegetable message in the Discussion Board of the Community Garden which should help. Go to the Historic Fairmount website, click on the Community Garden link, then the Discussion Board. You'll need to set up a username and password but there's some good information in there.

If you've lost some flowering plants to the heat. spend some time in the nursery for plants to fill the empty spaces. The reds and oranges that seem too hot to enjoy in the heat of summer will be radiant in September and October. Most of the flowering plants will produce thru until frost. If you've lost shrubbery, you may want to wait until early October to replace them.



At the tail end of August and early September you can sod or seed the bare spots in your lawn. Early September is also the time to apply corn meal gluten to your lawn to prevent spring weed seeds from germinating. Be careful not to get it in areas where your spring flowers are reseeding themselves. It's not discriminating between seeds.

If you have animals, you've probably been fighting fleas this summer. Many organic gardeners recommend food grade Diatomaceous earth ("DE") spread on your lawn as a preventative. DE will work but it's hard to spread and has to be reapplied after rain or watering. A longer lasting solution—and one that works for flies, grubs and fire ants as well as fleas is Beneficial Nematodes. Two applications 5-7 days apart is recommended but it's good for a number of years—until all the larva is depleted. According to one source, they control over 250 species of insects.

As the weather cools, I hope to see you in the gar-

RECEIVERSHIP: A TOOL FOR SAVING ENDANGERED HISTORIC HOUSES

Receivership is not a new legal term. It is a concept/law that has been on Texas books for many, many years. However, it was very seldom used in the past because it was cumbersome and required a long payback period for the potential receiver. Receivership is intended to (temporarily or permanently) take historic homes from neglectful owners and put them into the hands of responsible organizations or individuals before the houses experience "demo by neglect."

Last year, Fort Worth City Attorney Chris Moseley worked with the Texas legislature to craft a more "user friendly" receivership, and that revised statute is now in place.

Once a house is stabilized (and that can be from the very minimum—e.g., new roof and repaired foundation and replaced windows—to a more extensive restoration), the receiver is entitled to be reimbursed



for all expenses plus 10%, either by the previous owner or by any organization or individual wishing to buy the house. The former owner is not entitled to be reimbursed for any previous investment, and so the sales price can be very attractive to a new investor.

Historic Fort Worth, Inc., and City staff members have met with representatives from Fairmount to explain the process, so that we can determine if this new version of receivership can help us save more homes in Fairmount. We'll be learning more in the weeks and months to come and will share that information with you as it becomes available.





CITY COUNCIL ADOPTS OUTDOOR EVENTS ORDINANCE DESPITE NEIGHBORHOOD OPPOSITION

A new outdoor events ordinance, approved by the City Council last week, goes into effect Oct. 1. The Council unanimously approved the ordinance despite heavy opposition from Fort Worth neighborhoods, including Fairmount.

The ordinance applies to any outdoor gathering on public or private property that attracts more than 500 attendees, requires a street to be closed, sells food or beverages, or uses tents, stages, bleachers, fireworks, open flames or portable toilets. It would also apply to parades, neighborhood events requiring the use of city streets, events in parks and some First Amendment activity.

An advisory committee—supposedly made up of Fort Worth residents, "neighborhood advocates" (though none from Fairmount) and stakeholders who organize and manage outdoor events—met for more than a year to formulate new outdoor events policies and practices that were adopted into the ordinance.

Events conducted entirely on the property of a church, educational institution, college or university campus, or on property containing an occupied residence are exempt from the new ordinance. Additionally, events contracted with the city or at city-owned facilities and at the Texas Motor Speedway are exempt.

Event organizers will be required to attend two committee meetings—the Events Calendar Committee and the Pre-Event Committee—and must provide notice to surrounding property owners. The two committees will be in charge of scheduling events, reviewing event plans and applications.

The Fairmount Board is evaluating how the ordinance will affect long-standing neighborhood activities such as Home Tour and the Home Tour Parade.

BOARD NOMINEE AUTOBIOGRAPHIES

DIRECTOR OF HISTORIC PRESERVATION—SUE MCLEAN

As a resident of Fairmount since 1983, I became active in the Neighborhood Association in 1990 after my house was on Home Tour. I was Newsletter Director for 5 years in the 1990's and created the Home Tour brochures for several years. I took a 5 year break, then returned as Director of Infrastructure and assistant to the Director of Historic Preservation, Mike McDermott. Mike and I created the Historic Preservation Committee which meets each month to discuss the Certificate of Appropriate applications going before The Historic and Cultural Landmarks Commission to decide the recommendations for the District. Since taking over for Mike and finishing his term and then one term of my own, I attend the monthly HCLC meetings and present the Committee's recommendations on the cases.

As Director of Historic Preservation, I consult with home owners, investors and new home builders almost daily if not by email or phone, reviewing and meeting them at their projects, and often having to help some to do the right thing and restore, not remodel.

As the current Chairman of the Fairmount Guidelines Committee, we have spent the past 2 ½ years, (and gone through 2 other Chairpersons), with the overwhelming project of rewriting the District Guidelines to clarify them and to allow some new products to be used. They are now complete, just waiting on HCLC Staff to rewrite some of the City input, then will be submitted to them.

I began taking periodic photos of the over 1400 structures in the District in 2005, and after scanning the 1995 photos taken by the Fairmount Garden Club, and merging with others taken by Bill Walton prior to 2005, I created the Fairmount digital photo archives – which are now on the Fairmount website. I am currently working with the HCLC Staff to get digital copies of the rest of their 2000 photo survey to add, and they have just completed a new 2010 photo survey to go with the new Guidelines. Once we have them, we will be conducting a re-survey of the District, deciding which structures are contributing and which are not. We hope to rectify the original survey done in the late 1980's by the National Trust which was done very arbitrarily with houses that have even been on Home Tour which were inexplicably listed as non-contributing.

This position is a big job, and I have a lot of work yet to do ahead of me. So please allow me continue for another term, and vote for me.

DIRECTOR OF PUBLIC SAFETY—GERI COTTON

Twenty-six years ago, I bought a home at 2212 College Avenue that they told me could be condemned on the front outside alone. These have been very interesting, challenging and rewarding years. A group of us even set up a corporation to purchase and restore homes in Fairmount. These were the early years spent setting up the neighborhood association, in planning home tours, working on our national registry designation and the historic overlay, helping to rewrite the code for the City of Fort Worth, having a music festival on Magnolia Avenue and more. Helping curb crime in our neighborhood was an enormous part of reclaiming Fairmount for families so when we were asked to assist the police department, we volunteered. A graduate of Oklahoma State University in Interior Design, I've worked in design, real estate law, antiques, sales and currently in logistics/transportation. My hobbies are gardening and needlework. I'm married to Calvin Clayton, Citizens on Patrol Coordinator for the Fort Worth Police Department, Central Division.

DIRECTOR OF FINANCE—JANE WEDDING

My name is Jane Wedding. I have been a resident in Fairmount for almost two years. I moved to Fairmount at the suggestion of my brother, Robert, who is a Fairmount resident. I have since discovered for myself that all of the positive reasons he gave me for moving into the neighborhood are true indeed. Fairmount is a very friendly, dynamic, and resourceful place to live. And, the fact that it is an historic neighborhood is just "icing on the cake" for me.

I joined the Neighborhood Association when I arrived. I was a volunteer during the 2009 Home Tour, and my home was featured in the 2010 Home Tour. I am a member of the Fairmount Garden Club and Historic Fort Worth.

A DESIRE NAMED "STREETCAR": CITY UPDATES STREETCAR PLAN

On Monday night, August 9, at the Intermodal Transportation Center, a public input meeting on modern streetcars was held. Presenting were Charlie Hale of HDR Consulting Inc., the consulting firm charged by the City of Fort Worth with the preliminary study of the feasibility of streetcars in our city; and David Gaspers, Senior Planner in the Planning and Development Department of the City of Fort Worth.

After an introduction by Mr. Gaspers, Mr. Hale provided insight into the study to date. Details and further study will be presented to City Council in September with the final report in November.

Several different routes are under study, with emphasis on ridership, potential economic development as well as initial capital outlay and operation costs. By studying the different scenarios, HDR can help the City of Fort Worth determine which route would be the best starter route, if the City decides to move forward with Modern Streetcars.

Last month, the City of Fort Worth was awarded the largest potential grant by the Federal Transportation Department, \$25 million, to fund the beginnings of a modern streetcar system for Fort Worth. If implemented, matching funds would need to be provided, and most likely those funds would come from sources such as Tax Increment Financing Districts (TIFs) and Public Improvement Districts (PIDs). (Much of the improvements along Magnolia and other areas in the Near Southside has been funded by TIFs.) Other cities that have implemented streetcar systems, notably Portland Oregon, have found that the economic development that accompanies the streetcar grids provides a huge payback in the form of new property and sales taxes. Many other major cities across the nation are beginning to implement streetcar systems as an integral part of their public transportation system.

Other benefits of streetcar systems are improved air quality due to decreased automobile usage; and encouragement of higher density in the urban center, thus discouraging urban sprawl and its further dependence on cars and more highways.

One of the potential streetcar routes under consideration by HDR would come down Main Street and turn west on Magnolia to connect the hospital district with downtown Fort Worth and the Intermodal Transportation Center and thus a connection with light rail to DFW Airport and other destinations.

If the system is implemented, the first line would be chosen based on its potential for success. Other routes would be added incrementally.

FAIRMOUNT PRESIDENT AND PRESIDENT EMERITA MEET WITH HEAD OF TAD

In July, Patti Randle and I met with Jeff Law, Director of the Tarrant Appraisal District. We met with the purpose of seeking answers about the inequities of property appraisals within Fairmount.

Many have noticed and commented on the frequently gross differences between tax appraisals of owner-occupied properties, often numerous holdings by families and corporations (what many refer to as 'slum lords'). I specifically brought to his attention some holdings of a family with many Fairmount rental properties, whose valuations have not increased for the past three years while many other properties have increased every year.

Although we didn't get specific answers, Mr. Law was responsive and very open to our concerns and inquiries, giving us several examples of how the differences in appraisals might come about. The most likely scenario is that these particular property owners hire a tax consultant who consistently protests the appraisals and wins using the income approach to justify the appraisal protest.

(Property appraisals can be valued on sales price, comparable sales, or a "stream-of-income" approach. Properties which produce a low stream of income can use a formula to back into the "fair market value" and protest any increase in valuation based on that.)

Mr. Law was very gracious and wants to set up a meeting between representatives from Fairmount and his assessment team that actually appraises property in Fairmount, so we can help educate them about particular circumstances that are unique to Fairmount. Hopefully, with a better informed team, they can better apply the appraisal rules to everyone in Fairmount and help achieve a fairer appraisal system.

We'll keep you posted on any new events.

JULY YARD OF THE MONTH: 1257 W MORPHY

The yard of the month for August is the 1257 W Morphy cottage of Charlotte and Craig Burrell. The

couple has lived in Fairmount for four years sharing their home with cats Arty and Oscar, often seen sitting in the window looking out over the front courtyard, and dogs Jack and Chief, who eagerly greet you at the fence. Charlotte acts as garden designer and both she and Craig bring the plan to life.

The design celebrates early cottage gardens or as Charlotte calls them "Grandmother Gardens". Native and naturalized plants are incorporated into the design including flowering shrubs and trees, grasses, antique roses, perennials, and annuals. Plants are not only selected for seasonal interest but also as a buffet for native and migrating wildlife, building a multi-layered cottage garden. The garden's backbone is a mix of crepe myrtles, red berried possum haws, pink hawthorns and antique roses, as well as grasses and day-lilies. Salvia gregii and obedient plant bloom in the fall and poppies, guara, phlox, and hollyhocks in spring and summer. Annuals such as trailing periwinkle, sun-




flowers, zinnias, and pansies add splashes of color to the landscape throughout the seasons. Charlotte's favorite, moonflowers from seed shared by her neighbor the year she moved in, give nighttime passersby, visiting lunar moths and bees a fragrant treat. Plumbago, tricolored sweet potato vine, lavender, and lantana tumble from mixed pots on the porch and stoop.
